# PROGRAM UPDATES & ANNOUNCEMENTS

#### Crisis Response Program

- Our communication centre has connected with 2956 individuals either face to face or by phone/text this year.
- Safe Bed program has had 26 admissions so far, this fiscal year.
- Over the last 5 months, the IMPACT program has had 243 contacts with individuals and has made 436 community resources connections.
- 9-8-8 contacts to date: 44 calls and 229 texts.

#### Case Management, Justice & Housing

- Successfully facilitated the coordination of services for 190 clients.
- Welcomed a new Restorative Justice Courtroom, strengthened partnerships with landlords and community partners, and continued to support the Coordinated Housing Access Table to streamline services and reduce barriers for our homeless population.

## CLIENT CENTRED APPROACH

#### Case Management, Justice & Housing

Our local justice system has embraced a new streamlined restorative justice approach, directing individuals toward, and reducing barriers in accessing mental health diversion. This person-centered method acknowledges the influence of mental health on charges. Recently, our first case underwent this efficient process. One of our Court Support Workers, a staunch advocate, guided the client through the court proceedings, which resulted in conditional charges that will not have a detrimental effect on their well-being long-term. The client fulfilled the diversion requirements and is now prioritizing their healing journey.

A client under conditional discharge from the Ontario Review Board has been successfully living independently, with assistance from our Forensic Supportive Housing Program. This marks the client's first time living autonomously in seven years. With our program's support, the client is effectively managing their housing responsibilities and adhering to their medication regimen. They actively collaborated with our team to advocate for suitable housing and recently excitedly accepted an offered unit.





#### Crisis Response

Crisis staff are no strangers to teamwork and thinking outside the box. Recently, a 65-year-old client, who was stuck in Thunder Bay, was requesting help through our CMHA email account. The client was in a place where their life was at risk, however, was too afraid to share their location. Through a collaborative approach between phone staff, Mobile Response Team and TBPS, we were able to locate the client, gain their trust to have our Mobile Response Team attend to their location and eventually have them admitted to our Safe Bed for further support. Once in the Safe Bed, we were able to meet the clients needs, to provide addictions supports and to secure them a ride home within the region.

## CLIENT CENTRED APPROACH

#### **New Foundations**

New Foundations focuses on the principles of psychosocial rehabilitation (individualized client focused goal needs that are person directed, including employment opportunities, social supports/rec therapy, basic life skills and education). The greatest gift and honour is being present with our members and hearing their stories, and learning about their journey, the pitfalls and successes and what motivates them to find meaning in their lives. Without this ability to be present with our members, trust would languish, and the relationship would not blossom. It is in this partnership that growth feeds – for the self and for the community at large.

Our doors are open. No appointment necessary. Walk ins welcome.

# MEMBER SPOTLIGHT

"My name is Susan McGregor and I have been a member of New Foundations CMHA for 16 years. I first heard about this program when i was in the hospital and staff from CMHA would come as hospital outreach and talk with patients about the program. Since then, I have been coming to the program five days a week and occasionally on Saturdays for Social recreation. I partake in Transitional Employments, Catering and I make the lunches weekly. Since I started coming hear my confidence has improved significantly in public speaking, cooking, leadership, and social skills. CMHA has helped me come a long way with my depression. The staff are very warm and friendly, and all the members and staff have built a family like environment. I always look forward to coming to CMHA everyday knowing there is no judgement or discrimination." - Susan McGregor



## CLIENT CENTRED APPROACH

#### First Place Clinic

"First Place gave me an understanding of my son's illness and how I could support him in his recovery journey. With education they helped me manage my expectations, communicate better with respect and without judgement, and provide a healthy environment while his brain recovered from this psychotic event. It was very helpful to hear that they had great success treating people with first time psychosis and it was important, regardless of the mental health diagnosis, to try and prevent future psychotic events from happening. It was suggested that I see my son as a person who had suffered a heart stroke. It was then easier for me to understand that the recovery journey has no timelines and no specific destination. First Place support encouraged me to focus on things I could control and was a

focus on things I could control and was a key strategy to dealing with the unknowns in my son's recovery journey."

I always knew they were on my side, rooting for me in a way. Now that I am 20 years old, looking back on my 13-year-old self I don't know how I would or could have made it through all the tough times without the support and help of the staff at first place. I appreciate all that this clinic does for the people who truly need it!"

# **COMMITMENT TO RECOVERY**

### Crisis Response Program

Commitment to recovery is represented consistently in the work Crisis does with clients. Our Addictions Specialist plays a huge role in promoting recovery and advocating for clients to access treatment. The Addictions Specialist is instrumental in the operation of our addiction's pathway through Balmoral Detox, as well as setting up treatment dates for clients through working relationships built with treatment centres. Since last year, over 25 Safe Bed clients have been supported to access treatment by the Addictions Specialist and Safe Bed staff. The program has received testimonials from clients that describe it as lifesaving, healing, and inspiring.

Referral process to Derek (Addictions Specialist) for when you have clients that need that extra support with Substance Use issues. Please use the internal referral through our EMHware system. Please follow up with an email to dmartens@cmha-tb.on.ca when you complete the referral.

### There are different items that Derek can help with:

- Treatment referrals
- Connection to other agencies
- Information gathering on services
- General conversation on items they may be struggling with
- Harm reduction
- GAIN short screener (Full GAINQ3 is done through Thunder Bay Counselling), and other assessments.
